OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE CONTEST, AND NO PURCHASE WILL INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. AS A CONDITION TO ENTER THIS CONTEST, YOU WILL BE REQUIRED TO ASSIGN SOME OF YOUR RIGHTS IN YOUR ENTRY TO THE SPONSOR. PLEASE READ THE ENTRY REQUIREMENTS BELOW FOR DETAILS.

1. **SPONSOR:** The Sponsor of the “DeLaval Cow Tales Video” Contest (the “Contest”) is DeLaval Inc., 3000 Lakeside Drive, Suite 305 South, Bannockburn, IL 60015 (“Sponsor”). The “Contest Entities” means Sponsor and its parents, subsidiaries, affiliates, owners, managers, officers, employees and their advertising agencies, promotional partners and prize providers as associated with the Contest (each individually a “Contest Entity”). The Contest is not sponsored, endorsed or administrated by, or associated with, Facebook in any way.
2. **CONTEST PERIOD:** Contest begins at 8:00 a.m. CDT on **Monday, June 22, 2020 and will end at 5:00 p.m, CDT on Friday, June 26, 2020** (the “Contest Period”).
3. **ELIGIBILITY:** The Contest is open to legal residents of the fifty (50) United States (including the District of Columbia) and Canada who are at least eighteen (18) years of age on the entry date and who have a Facebook account. Employees, agents, officers, directors, members, managers, and owners of Sponsor or any Contest Entity, and each of their immediate family members (spouse, parents, legal guardian, siblings, and children) and those individuals living in their same household are not eligible to enter or win. Sponsor reserves the right to verify eligibility of all entrants, and entries submitted by entrants who do not meet the eligibility requirements are void. The Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited by law.
4. **HOW TO ENTER:** During the Contest Period, (i) take one (1) original video of you and your favorite cow or calf, explaining why they are your favorite (“Video”). (ii) visit Sponsor’s Facebook page at “www.Facebook.com/DeLavalUS or <https://www.facebook.com/DeLavalCA/>” and find the “**DeLaval Cow Tales Video**” post announcing the Contest (“Post”); (ii) submit your video in the comments section of the Post. Limit one (1) video per Facebook account during the contest period. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed to be submitted by the person in whose name the Facebook account is registered on the date the entry is submitted.
5. **WINNER SELECTION AND NOTIFICATION:** Sponsor will judge and select one (1) winner from the eligible entries submitted during the Contest Period between the two (2) contest posts on DeLaval Canada and DeLaval US Facebook pages. Contest entries will be judged by Sponsor in accordance with the following judging criteria: Originality (50%), Creativity (30%) and Sincerity (20%) (“Judging Criteria”). The winner will be selected by Sponsor in its sole discretion and will be deemed the potential winner (the “Potential Winner”). Sponsor will notify the Potential Winner via Facebook. If the Potential Winner does not respond to the prize notification by the indicated deadline and/or in the manner described in the notification from Sponsor, he/she will be disqualified and an alternate winner will be selected by Sponsor based on the Judging Criteria (“Alternate Potential Winner”). Sponsor will repeat the winner selection procedures set forth in this section until a qualified winner has been selected. Upon Sponsor’s request, a Potential Winner or Alternate Potential Winner may be required to sign and return an Affidavit of Eligibility and/or a Release of Liability/Publicity Release to be eligible to win and/or claim the Prize. Winners will be announced via Sponsor’s Facebook and/or Twitter accounts. A Potential Winner who is a Canadian resident must correctly answer a time-limited mathematical skill-testing question, without assistance of any kind (whether mechanical or otherwise) administered at a mutually agreeable time to claim a prize, otherwise the prize will be forfeited.
6. **PRIZE:** There will be four (4) prizes available for the top four (4) winning participants. The (“First Place Prize”) will consist of one (1) DeLaval swag pack. . Approximate retail value (“ARV”) of the “First Place Prize” is \$100.00 USD. The (“Second Place Prize”) will consist of one (1) DeLaval swag pack. Approximate retail value (“ARV”) of the “Second Place Prize” is \$75.00 USD. The (“Third Place Prize”) will consist of one (1) DeLaval swag pack. Approximate retail value (“ARV”) of the “Third Place Prize” is \$50.00 USD. The (“Fourth Place Prize”) will consist of one (1) DeLaval swag pack. Approximate retail value (“ARV”) of the “Fourth Place Prize” is \$25.00 USD. No cash or other substitution, assignment or transfer of any Prize is permitted, except by Sponsor, who reserves the right to substitute the Prize or prize component with cash or another prize of comparable or greater value. 9. **ADDITIONAL ENTRY RIGHTS/CONDITIONS:** Sponsor and the Contest Entities will have the right to edit, adapt, publish and otherwise exploit any or all of the entries (which shall be deemed to include without limitation the Photo and any personal or identifying information about the entrant contained in the entry except where prohibited by law), and may use them in any media now or hereafter known or devised throughout the universe in perpetuity for any purpose without attribution or compensation to the entrant, his/her successors or assigns, or any other entity. 12. **DISPUTES:** Except where prohibited, as a condition of participating in a Contest, each entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with the Contest or any Prize awarded will be resolved individually, without resort to any form of class action, and brought exclusively in the appropriate state or federal court located in the State of Illinois, and each entrant accepts and submits to the personal jurisdiction of these courts with respect to any disputes, claims, causes of action, legal actions, suits or proceedings arising out of or related to a Contest; (ii) any and all claims, judgments and awards on behalf of entrant will be limited to actual out-of-pocket costs incurred, if any, but in no event attorneys' fees, and in no event to exceed two hundred fifty dollars (\$250.00); (iii) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses not to exceed two hundred fifty dollars (\$250.00), and waives any and all rights to have damages multiplied or otherwise increased; and (iv) the Contest and any dispute arising under or related thereto (whether for breach of contract, tortious conduct or otherwise) will be governed by the internal laws of the State of Illinois without giving effect to its conflicts of law or choice of law principles or rules that would cause the application of any other state's laws.
